Easy Flex – Fractional Yacht Ownership FAQ

1. What is Easy Flex?

Easy Flex offers fractional ownership of luxury yachts, allowing several co-owners to share the cost, usage, and benefits of yacht ownership without the hassles of maintenance or management.

2. How does fractional ownership work?

Each yacht is divided into ownership shares or more per owner. Each owner receives guaranteed access to the yacht for a proportional number of weeks per year. All operational, financial, and legal aspects are managed centrally by Easy Flex.

3. What are the main costs involved?

1. Share purchase price – your equity in the yacht.
2. Quarterly maintenance fee – covers marina fees, fuel, crew, and upkeep (pro-rata to ownership %).
3. Annual management fee – insurance; Accounting & Reporting; Digital Platform; Concierge; Turn around between owners; Time management and Total Owner Experience management.

4. Can i join the Easy Flex program with 100% ownership?

5. What does Easy Flex handle for me?

Everything: registration, insurance, accounting, maintenance, crew recruitment, logistics, scheduling, and transparent financial reporting. You simply choose your sailing weeks, arrive, and enjoy.

6. How is usage time allocated?

Owners book time through Easy Flex's digital platform, which ensures fair distribution via an algorithm that rotates prime weeks (holidays and peak seasons) annually among co-owners.



7. Who operates the yacht?

Each yacht is fully crewed year-round with a professional skipper and hostess. The crew manages navigation, safety, and guest experience, ensuring each stay is effortless and luxurious.

8. Where are the yachts based?

Easy Flex yachts are stationed in premium Mediterranean destinations — Greece, Croatia, and Italy — with future expansion planned for other European marinas.

9. What happens at the end of the 5-year ownership term?

At the end of each 5-year term, co-owners may:

- Renew the ownership agreement,
- Sell the yacht (proceeds distributed by ownership %), or
- Upgrade to a new yacht through Easy Flex's next-generation fleet.
- Easy Flex will buy your share

10. How is resale handled?

Owners may sell their share at any time, subject to a Right of First Refusal by other co-owners. Easy Flex assists in marketing and coordinating the transfer through a transparent process.

11. What safeguards protect co-owners' interests?

Each yacht operates under a legal co-ownership agreement and a detailed usage bylaw that defines rights, obligations, and dispute-resolution mechanisms. Funds and accounts are independently audited.

12. Can I charter the yacht when I'm not using it?

Yes — subject to owner consensus and Easy Flex approval. Charter income is shared among owners proportionally, providing potential yield.
